Summary

Water rights encumbered by conservation easements restrict the ability of the landowner to use those rights anywhere but on the property receiving the conservation easement, thereby tying the water to the land. To compile this report, every deed of conservation easement pertaining to properties within the boundary of the Upper Gunnison River Water Conservancy District (UGRWCD) was read for information about water rights. These conservation easement deeds are available from the public records of the Clerk and Recorder of Gunnison County, Hinsdale County and Saguache County.

This report provides a list of approximately 490 water rights within the UGRWCD that are restricted in some manner by conservation easements. There are seven types of restrictions, and tables are provided that sort the water rights into each of these types.

A sortable Excel spreadsheet accompanies this report. Information for each water right is provided on the tables and the spreadsheet for the following: WDID, Water Source, Ditch Name and Number, Priority Number (if available), Appropriation Date, Quantity, Administration Number, Water Court Case, Conservation Easement Name, and Recorded Document # for the Conservation Easement. Water rights information is from the Colorado Division of Water Resources website.

This report was funded jointly by the Upper Gunnison Water Conservancy District and the Gunnison Ranchland Conservation Legacy.

Conservation Easements and Water Rights: A Summary

A conservation easement is a voluntary legal agreement between a landowner and a land trust or government agency that permanently limits uses of the land in order to protect its conservation purposes.

Conservation purposes are defined by federal statute. Pursuant to I.R.C. § 170(h)(4)(A) and Treasury Regulation § 1.170A-14(d), the conservation purposes of a qualified conservation contribution must include one or more of the following: (1) to preserve land for outdoor recreation by or education of the general public; (2) to protect relatively natural habitat of fish, wildlife or plants; (3) to preserve open space, such as productive agricultural and forest lands; and (4) to preserve historically important land or structures.

Conservation easements are recorded in the public records of the county in which the conserved property is located. The easements are attached in perpetuity to that land and, as public documents, are discovered during title searches. Each conservation easement cites the conservation purposes (also called "conservation values") for that particular property.

Conservation easements place permanent restrictions on division of land in order to perpetuate the conservation values. This means the land covered by the easement will forever be a single parcel, with very few exceptions. If the conservation easement includes more than one legal parcel of land, those parcels must be owned and conveyed as a single unit in perpetuity. Easements define specific areas for residential or agricultural structures. Roads and driveways are restricted, as are other surface disturbances such as mineral exploration or exploitation.

Conservation easements have been in use for more than 100 years, but the past 50 years have seen exponential growth in this form of voluntary private land preservation. Many court cases have upheld the validity of conservation easements and the restrictions they place on landowners in perpetuity.

The definition of the property receiving a conservation easement includes any water rights necessary to sustain the conservation values articulated in the deed of conservation easement. Water rights language appears in the body of the document, and in most cases the water rights that are encumbered by the conservation easement are listed in an exhibit to the document.

The reason for encumbering water rights is to ensure that the resources required to perpetuate irrigated agriculture and wildlife habitat on the particular property will be present forever. That is why most water language in conservation easements states that "Grantor shall not transfer, encumber, lease, sell or otherwise separate such quantity of water rights from title to the Property itself." This or similar language is present in many of the conservation easements in the UGRWCD.

However, water language differs in some conservation easements, depending on the land trust's own template language and attitude toward water, and also on whether any funders or partners in the process of placing the conservation easement required specific water language.

The water rights language in the conservation easements within the UGRWCD boundaries is generally of seven types. The following tables show those water rights encumbered by each type of language. The last table, and the accompanying Excel spreadsheet, show all encumbered water rights, with a code reflecting which type of language applies to each water right.

Table A: Water Rights for Which Leasing Is Prohibited

Examples of conservation easement language that prohibits separation of water rights from the property, including leasing:

“Grantor shall retain and reserve the right to use water rights sufficient for use in present or future agricultural production on the Property, and shall not transfer, encumber, lease, sell or otherwise separate such quantity of water rights from title to the Property itself.”

“Grantor shall retain and shall not transfer, encumber, lease, sell, or otherwise separate any existing water rights which are presently used or necessary for the operation of the ranch, including maintaining the irrigated hay meadows, or for preservation of the Conservation Values, including maintaining wildlife, fisheries, and recreation uses, and the riparian area and the quality and quantity of water in the Lake Fork of the Gunnison River, from title to the Property.”

“Grantor shall not transfer, encumber, sell, lease or otherwise separate the Water Rights from the Property.”

“Grantor shall retain and reserve the right to use the Water Rights or that portion sufficient to maintain and improve the Conservation Values of the Property, and shall not transfer, encumber, lease, sell or otherwise separate water rights necessary and sufficient to maintain and improve the Conservation Values of the Property from title to the Property itself.”

“Grantor shall retain, reserve, and preserve the right to use on the Property the water rights appurtenant to or associated with the Property as of the date of this Deed, which water rights are essential to the maintenance of the Property’s Conservation Values, and shall not transfer, encumber, lease, sell or otherwise separate such water rights from the Property.”

Table B: Water Rights That Can Only Be Leased for Instream Flows

Examples of conservation easement language that prohibits separation of water rights from the property, except for instream flows:

“The Grantor may not sever any water rights from the Property except to legally designate those water use rights for instream flows.”

“[Grantor] may, on occasion and as permitted under CRS §37-83-105, temporarily loan one or more of the Water Rights to the Colorado Water Conservation Board for instream flow purposes;”

“Subject, however, to the right … to utilize certain of the water and water rights, ditch and ditch rights to protect and preserve the historic flow of water in Ohio Creek for fish preservation and growth purposes.”

“…Grantor may enter into temporary legally enforceable water leases, contracts, emergency water loans, or similar agreements for conservation purposes, not to exceed three consecutive years or five out of every ten years, to increase instream flows and or water levels in streams, rivers, lakes, and reservoirs to preserve or improve the natural environment of such water body(s), provided that (1) Grantee has given its prior written consent to such arrangements; (2) that such use, in the opinion of Grantee, would not jeopardize the long-term Conservation Values of the Property; (3) that such arrangements do not permanently separate the Water Rights from the Property; (4) that such arrangements comply with current law; and (5) that Grantee has provided written notice to the Board.” *[Note: Board = GOCO].*

“The Grantor shall not transfer, lease, sell or otherwise separate the Water Rights from the Property, except that with the prior approval of the Grantee (if the Grantee determines in its reasonable discretion that such transfer will not adversely affect the Conservation Values of the Property), Grantor may transfer by any lawful means (including as described in C.R.S. §37-92-102(3), as amended from time to time), a portion of the Water Rights to the Colorado Water Conservation Board (“CWCB”), or any other governmental or non-profit conservation organization qualified under C.R.S. §38-30.5-104(2) that may be permitted by law to lease or hold title or make use of water rights for the public or charitable purpose of preserving in-stream flow (the “In-Stream Use.”).”

Examples of conservation easement language that allows the leasing of water rights from for temporary one-year renewable terms:

“Grantor shall not transfer, encumber, sell, lease or otherwise separate the Water Rights from the Property...” “Temporary (one-year renewable) leases or transfers as permitted by State law are allowed, provided said leases or transfers are not inconsistent with the preservation and protection of the Conservation Values.”

“Grantor shall not transfer, encumber, sell, lease or otherwise separate the Water Rights from the Property, except that permanent alternate points of diversion are allowed, as are temporary (one-year renewable) leases or transfers.”

“Grantor shall not transfer, encumber, sell, lease or otherwise separate the Water Rights from the Property, except that permanent alternate points of diversion are allowed, as are temporary (one-year renewable) leases or transfers as permitted by State law regarding drought conditions.”

Example of conservation easement language that allows the leasing of water rights from for a 10-year term:

“Grantor shall not permanently transfer, encumber, sell, lease or otherwise separate the Water Rights from the Property...Grantor may enter into temporary water leases or transfers, the terms of which for each respective lease or transfer shall not individually exceed ten (10) years, to allow the use of the Water Rights off of the Property as permitted by State law, provided that: (i) Grantee has given its approval to a proposed temporary water lease or transfer pursuant to Section 25 (Grantee’s Approval) and based on its determination in its sole discretion that the proposed temporary water lease or transfer would not have long-term, negative impacts on the Conservation Values of the Property and (ii) the temporary water lease or transfer does not permanently separate the Water Rights from the Property.”

Examples of conservation easement language that allows the leasing of water rights that are determined to be unnecessary for perpetuating agricultural production:

“Grantor may transfer, encumber, lease, sell, or otherwise separate from the Property such portion of the Water Rights which Grantor demonstrates to Grantee’s reasonable satisfaction are not necessary for the present or future agricultural production on the Property.”

“Grantor shall retain and reserve the right to use water rights described in Exhibit D (the “Water Rights”) for use in present or future agricultural production on the Property, and shall not transfer, encumber, lease, sell, or otherwise separate the Water Rights from title to the Property itself; provided that Grantor may transfer, encumber, lease, sell, or otherwise separate from the Property such portion of the Water Rights which Grantor demonstrates to Grantee’s reasonable satisfaction are not necessary for the present or future agricultural production on the Property.”

“Grantor shall retain and reserve the right to use water rights sufficient for use in present or future agricultural production on the Property and to maintain the Conservation Values of the Property, and shall not transfer, encumber, lease, sell, or otherwise separate the Water Rights from title to the Property itself... Grantor may transfer, encumber, lease, sell, or otherwise separate from the Property water rights which Grantor has demonstrated to the Conservancy’s reasonable satisfaction are not necessary for present or future agricultural production on the Property or to maintain the Conservation Values of the Property.”

Examples of conservation easement language that allows the leasing of water rights that are determined to be unnecessary for perpetuating the conservation values of the property:

“The Grantor may sell, lease or otherwise separate water rights from the Property not required to maintain and improve the Conservation Values of the Property.”

“Grantor...shall not transfer, encumber, lease, sell or otherwise separate the water rights sufficient to maintain and improve the conservation purposes of the Property from title to the Property itself. Grantor may sell, lease or otherwise separate water rights from the Property not required to maintain and improve the conservation purposes of the Property.”

“The Water Rights may not (a) be changed to or used for municipal, industrial, non-agricultural or non-ranching commercial uses, or other new uses, (b) be changed for use other than on the Property, (c) be sold or encumbered separately from the Property or otherwise be legally separated from the Property, or (d) have their points of diversion, or their type or place of use within the Property substantially changed, except after a written determination by Holder in its sole judgment that such change, sale or encumbrance, does not impair the Conservation Values of the Property. Landowner may enter into temporary leases or transfers as permitted by State law, provided said leases or transfers have been approved by Holder and are consistent with the Conservation Values.”

“The Water Rights may only be leased or encumbered separately from the Property or otherwise legally separated from the Property (i) for beneficial conservation purposes which do not harm the Conservation Values of the Property as determined by the Conservancy in its sole discretion, and (ii) as contemplated by the Water Rights Operating Agreement...”

“Grantor shall not transfer, encumber, sell, lease or otherwise separate the Water Rights without the prior written consent of, and determination by, Grantee that such change is not inconsistent with the preservation and protection of the Conservation Values.”

“The Water Rights may never (i) be changed to or used for municipal, industrial, commercial uses, or other new uses, (ii) be changed for use other than on the Property, (iii) be sold, leased, encumbered separately from the Property or otherwise legally separated from the Property, or (iv) have their points of diversion, or their type or place of use within the Property changed, except after a written determination by the Conservancy in its sole judgment that such changes do not impair the Conservation Values of the Property.”

Examples of conservation easement language that allows the leasing of water rights only with approval from Colorado Parks and Wildlife:

“Grantor shall retain and reserve the right to use water rights sufficient for use in present or future agricultural production on the Property, and shall not transfer, encumber, lease, sell, or otherwise separate such quantity of water rights from title to the Property itself. Existing water rights for the Critical Area of the Property are shown on Exhibit C. Grantor may transfer, encumber, lease, sell, or otherwise separate from the Critical Area of the Property only those water rights which grantor has determined to the reasonable satisfaction of the Colorado Division of Wildlife are not necessary for present or future agricultural production on the Critical Area of the Property or to maintain the conservation values of the Critical Area of the Property.”

“Grantor shall retain and reserve the right to use water rights described in Exhibit D (the “Water Rights”) for use in present or future agricultural production on the Property, and shall not transfer, encumber, lease, sell, or otherwise separate such quantity of water rights from title to the Property itself; provided that Grantor may transfer, encumber, lease, sell, or otherwise separate from the Property such portion of the Water Rights which Grantor has demonstrated to the reasonable satisfaction of the Colorado Division of Wildlife are not necessary for present or future agricultural production on the Property or to maintain the Conservation Values of the Property.”
